GENERAL TERMS & CONDITIONS:

- 1) The bid shall be accompanied with the latest available Sales Tax, Service Tax & VAT certificate, PAN number should also be indicated in the Bid.
- 2) Reputed firms who have experience in the similar nature work may send their lowest offer for the same in sealed envelopes super-scribing "Quotation for Plastic Cans", in person / By post / By Courier as to reach the Film Preservation Officer, National Film Archive of India, Law college Road, Pune on or before 07/07/2017 up to 3.00 PM. The bids will be opened on the same day at 4.00 PM.
- 3) Pre-qualification criteria: Only the firms satisfying the following pre-qualification criteria would be considered for financial bid opening:
 - a. The bidder should be a Company Registered under Indian Companies Act, 1956 OR A partnership firm registered under Indian Partnership Act, 1932.
 - b. The bidder must have minimum annual turnover of INR 10 lacs (Rupees Ten Lakhs only) in each of the last three financial years i.e. FY 2013-14, FY 2014-15 and FY 2015-16.
 - c. The bidder should have satisfactorily executed at least 1 project of value INR 5 Lakhs for supply of similar cans during last 3 years.
- 4) The bidder shall submit all the documents necessary as proof to satisfy the prequalification criteria as mentioned in clause 3 above.

- 10) The Component Authority reserve the right to accept any offer or reject all of them without assigning any reason thereof. No correspondence will be entertained by NFAI, Pune in this regard.

- 11) The amount of offer should be quoted in Indian Rupees (in figures as well as in words) exclusive of all taxes. In case of discrepancy, the amount quoted in words shall be treated as valid.
- 12) The bidder should clearly mention VAT and all other charges legally applicable on the services/Goods in respect of this work/Supply and NFAI, Pune will not entertain any claim whatsoever on this account.

A) CAN - CONTAINER'S LID (TOP) part:-

- 1) Grove (1mm height): One circular grove of 2.5mm width (elevated from inside to outside curvature grove) on corner of lid (top) –130mm away from the centre point of Lid and one more circular grove of 1.5mm width (elevated from inside to outside curvature grove)– away 70mm from centre point of Lid (as Labeling area)
- 2) Thickness 1.50 mm
- 3) Outer Diameter 270 mm
- 4) Outer Height: 32mm

B) CAN - CONTAINER BASE (BOTTOM) part:-
