The National Film Archive of India (NFAI) was established in February, 1964 as a media unit of the Ministry of Information & Broadcasting, Government of India. The mission of NFAI is to safeguard the heritage of Indian Cinema for posterity and act as a Center for dissemination of a healthy film culture in the country. Recently, Government of India launched the National Film Heritage Mission that aims to achieve preservation, digitization, restoration and conservation of filmic heritage. NFAI has a collection of approx. 1,32,000 film reels, 1,50,000 photos, 22,000 posters, 13,000 song booklets, 3,000 pamphlets, 1,00,000 press clippings, and 29,000 books.

NFAI has three multipurpose theatres at its phase-1 and phase-2 premises. The theatres have been renovated and equipped with the modern DCP projection facilities and it has the feature of playing 3D films. NFAI is looking to install 3D Cinema Silver Screen in order to make it compatible with the existing DCP projection facilities.

As a part of this mission, NFAI intends to discuss with the professionals/organizations/agencies for setting up of 3D compatible cinema screens at NFAI phase I & II.

The formal process for engaging with the professionals/organizations/agencies shall be through the Government tendering process and would be initiated as per GFR rules. However, NFAI intends to understand the technical specifications/requirements views/opinions of the professionals/organizations/agencies who are presently working in the above said domain, so that a right and optimal approach can be identified towards executing the above said work.

In order to understand the views of the various professionals/organizations/agencies in the above mentioned areas, a meeting has been organized on 7th March 2018 on 1100 hrs in conference room of NFAI at Law College Road in Pune. After the meeting the vendors will be provided an opportunity to visit the theatres facilities and to come up with the technical specifications/ requirements for the Silver Screens to be used. Based on the observations during the site visit interested professionals/organizations/agencies can discuss with NFAI officials.
