## 1 Under Section 4.25, Performance Bank Guarantee the following changes have been made

Original clause - "In addition to the PBG, the Bidders are also required to submit a valid Bank Guarantee of the 110% of the mobilization advance made to the Selected Bidder which shall be valid till the work under the advance is successfully completed",

### Hereinafter to be read as,

"In addition to the PBG, the Bidders are also required to submit a valid Bank Guarantee of the **110% for any advance made to the Selected Bidder** which shall be valid till the work under the advance is successfully completed."

The rest of the Section 4.25, Performance Bank Guarantee remains the same as mentioned in the RFP for Digitization of film content.
