Notice Inviting Quotation

Subject: Internet Lease Line Connectivity between Phase I and Phase II at NFAI

The National Film Archive of India (NFAI) was established in February, 1964 as a media unit of the Ministry of Information & Broadcasting, Government of India. The organization has two offices, one at Law College Road (Phase-I) and another at Kothrud (Phase-II, behind Doordarshan office). As part of connecting the two offices (Phases) through internet, NFAI has published this NIQ for selection of a reputed Indian Firms/Agencies/Govt. licensed firms for 20 Mbps Internet Connectivity Leased Line (1:1) uncompressed & unshared with last mile on fiber/RF.

1. Checklist

The following items must be checked before the quotation is submitted:

Sealed quotations are invited for undertaking internet leased line connectivity between Phase I and Phase II at NFAI. The sealed quotations should be submitted at the National Film Archive of India, Law College Road, Pune.

3. Scope of Work

- The bidder needs to provide 20 Mbps Internet leased line connectivity on uncompressed, unshared leased line (1:1) on rental basis.
- 2) The minimum guaranteed bandwidth to be taken from the successful Bidder is 20 Mbps.
- 3) The hardware and software required for the establishment of fully functional leased line will be provided by the bidder on rental basis.
- 4) The bidder is responsible for Installation, commissioning, testing & up keep of the complete link for one year.
- 5) Initial engagement of the successful bidder shall be for one year only.
- 6) Engagement period may be extended by one year at a time, on the basis of need and satisfactory performance, up to a maximum of 3 years.
- 7) It shall be the responsibility of the Bidder to undertake all the activities that are required to successfully complete the work within the stipulated time as required by NFAI.
- 8) The bidder would ensure that the local loop provisioning does not violate regulations as laid by Government of India/TRAI in respect of such links/networks. Bidder will be responsible for making all the payments towards the local loop charges/rentals/WPC charges, etc.

- a. The detailed Pre-qualification criteria is appended in **Section 8**. The prospective bidders need to qualify the same to be eligible for further evaluation.
- b. Detailed financial proposal parameters are in the Annexure-II.
- c. The interested firms to whom the NIQ has been shared are hereby requested to furnish their proposal / rates by submitting their commercial quotes in the formant as provided in **Annexure-II**.

4. Service Level Agreement

The following are the service level agreements that selected bidders need to comply with:

- 1) **20 Mbps Internet** bandwidth at all the time.
- 2) **Packet Losses**: Less than 1 % (Average over 1000 ping) at any given point of time to any part of globe.
- 3) Latency: Less than 350 ms from SAU to ISP's tier 1 peering point.
- 4) Network Availability: Not less than 98 % per quarter.
- 5) Reports for performance, monitoring /usage to be submitted by the ISP on weekly or monthly basis.

5. Penalty on non-adherence to SLAs:

- For any violation in meeting the above SLA requirements, NFAI shall impose a penalty of 0.2 % of total value of purchase order and up to 5 % maximum penalty.
- The penalty amount would be calculated and deducted on quarterly basis as may be decided by NFAI from time to time.

<u>6. Terms and Conditions</u>

The other terms and conditions for awarding of the work shall be as mentioned below:

- i. Sealed quotation is to be submitted on the Firm / Company letter head
- This Notice for Inviting Quotations (NIQ) is for limited Bidders only and the Bidder who have received a copy of this NIQ shall only be eligible for submitting a response. Bid responses submitted by ineligible Bidders shall not be accepted by NFAI and will be summarily rejected.
- iii. Sealed quotation should reach Administrative Officer, National Film Archive of India, Law College Road, Pune- 411 004. on or before 28th August 2019 up to 3 pm.
- iv. Financial Envelope and Prequalification envelop should be in a sealed envelope and in-turn should be put in a single large envelope which should be sealed and super-scribed "Quotation for Internet Lease Line Connectivity at NFAI"
- v. NFAI also reserved the right to annul this NIQ process without assigning any reason what so ever.
- vi. The quantities mentioned in the financial table are indicative in nature and the actual procurement/work may vary.
- vii. The Bidder will provide one qualified bid response only.
- viii. The time period of the contract shall be one year and the rates quoted shall be valid for the entire duration of the contract period.
- ix. The payment to the Bidder shall be as per the quantity of the work done and basis the unit rate quoted only. No advance payment in any case would be made to the Bidder.

- x. Late submission of response will not be accepted by NFAI. Also, response submission on email will not be entertained.
- xi. The quotations received in unsealed manner will be straight away rejected.
- xii. The rates quoted by the bidder should be inclusive of all applicable taxes.
- xiii. This NIQ is not transferable.
- xiv.NFAI reserves the right to accept or reject any or all bid responses without assigning any reason whatsoever.
- xv. The Bidder shall be responsible for all the cost associated with this response. The bidder shall also be responsible for all the loss or damage caused to any of the material at NFAI owing to negligence on his part.
- xvi. The successful Bidder has to deposit Rs. 5,000 (Rupees Fifty Thousand only) in form of a Demand Draft drawn in the name of "Administrative Officer, NFAI" and payable at Pune as a Performance Bank Guarantee that shall be interest free and refundable only after satisfactory completion of the contract / work.

7. Earnest Money Deposit (EMD)

- a) Bidders shall submit, along with their Bids, EMD of Rs. 5,000 only, in the form of a Bank Guarantee (in the format specified in section 9.4) issued by any Scheduled bank in favor of "Administrative Officer, NFAI", payable at Pune, and should be valid for 6 months from the submission date of the Bidders Bids.
- b) EMD of all unsuccessful Bidders would be refunded by NFAI within one month of the Bidder being notified of being unsuccessful. The EMD, for the amount mentioned above, of the successful Bidder would be returned upon the submission of Performance Bank Guarantee as per the format provided in Annexure IV.
- c) The EMD amount is interest free and will be refundable to the unsuccessful Bidders without any interest accrued on it.
- d) The Bid / Proposal submitted without EMD, as mentioned above, will be summarily rejected.

8. Pre-Qualification Criteria

This Prequalification criteria documents shall be submitted in a separate sealed envelope (Envelop A-1) and the same shall be opened by the technical evaluation committee of NFAI in presence of the Bidder who wish to attend.

The Prequalification criteria is as follows:

- 1) Bidder should have a UASL / UL License. A copy of the same is to be provided by the prospective bidder.
- 2) ISP should be in the business of providing telecom services at least for last 10 years.
- 3) ISP should have ISO Certificate 27001.
- 4) The prospective bidder should have a portfolio that constitutes product offerings spanning across connectivity, collaboration, IOT & security solutions; so as to enable the organization to avail of diverse services under one roof and help service manageability.
- 5) The bidder should have a minimum average annual turnover of Rs. 5000 crore during last 3 financial year. The bidder needs to submit an Audited Profit & Loss Statements for last three financial years (2015-16, 2016-17 & 2017-18) and a CA certificate.
- 6) The bidders should have Direct/ toll free number to register complaints round the clock (24x7), Maintenance support service (24 hours and 7 days a week) (Attach Certificate)
- 7) The bidder must provide copy of Work Orders & work completion certificates showing experience in provisioning of similar services during the last three years (to be counted from the last date of submission of bids). During this period, the bidder should have provisioned or be running similar services (20Mbps or higher ILL) for at least five clients.
- 8) The Agency/ Organization/Company should not have been blacklisted or barred by Government of India (GoI) / any other entity of GoI or blacklisted by any state government or central government / department / Urban local body In India or from abroad either individually or as member of a Consortium. A Self-Declaration letter by bidder on the bidder's letter head. (As per Annexure- 3).
- 9) The Agency/ Organization/Company should have atleast 10 technical staff related to the

work. A Letter from HR on company letter head as per Annexure-V is required to be submitted by the bidder. Also, the CVs of the 10 technical staff that will be deployed for the said work at NFAI needs to be provided by the bidder.
